HAVING REGARD TO the University Regulations governing University Master's Degrees and Advanced Training Courses, professional refresher courses, and preparation for state examinations to qualify for the exercise of professions and public competitions;

#### **ARTICLE 1 - Establishment**

The University of Modena and Reggio Emilia activates, according to D.M. 270 of 22/10/2004, for the Academic Year 2023/2024, the II-level University Master Programme in *Development, Manufacturing, and Authorization of Biopharmaceuticals*.

## **AUDITORS**

It is possible to participate in the Master as an Auditor.

Those interested can apply as auditors directly to the organizational office of the master (email [master.biopharmaceuticals@unimore.it](mailto:master.biopharmaceuticals@unimore.it)), sending a pre-enrolment form (see Annex C) that must be filled in and submitted by the deadline indicated in the call for application. Once the activation of the master has been confirmed, a request for completion of enrolment will be sent with the simultaneous payment of the enrolment fee.

The organizational office of the master will inform those interested directly of the acceptance of the application as well as the timing and process for the enrolment and payment of the fee for participation in the Master as auditors.

The Auditors do not take the final exam, are not obliged to attend, do not participate in the internship, are not obliged to prepare the project work, do not acquire the title of II level University Master Programme in Development, Manufacturing, and Authorization of Biopharmaceuticals, and do not acquire CFU. The organizing secretariat will issue the auditor a certificate of attendance.

**Professional profile that the Master Programme intends to train:**

Over the last decade, radical changes in products developed and marketed by the biopharmaceutical industry, as well as a growing interest in improving the efficiency and effectiveness of production, have encouraged an evolution in the technologies and processes in use to produce the latest generation of biopharmaceutical products.

The Master aims to train experts able to manage the different processes of industrial development of laboratories with biotechnological and pharmacological characterization, to respond to the growing demand for highly qualified operators from companies and institutions in the sector.

The master aims to prepare specialized personnel with a high level of qualification, able to cover various professional positions within the biopharmaceutical drugs world. These professionals will be qualified as:

- **Manager/Director of laboratories** with biotechnological and pharmacological characterization.
- **Coordinator of development and monitoring programs** of applied biotechnologies in human health, regarding the industrial development of biopharmaceutical products, the industrial aspects of biotechnological drugs production, and the management of scientific and process-related data with artificial Intelligence (AI).
- **Expert in management of the regulatory aspects of the market authorizations, of the ethical** and legal implications of the marketing of biopharmaceuticals with aspects of environmental protection and sustainability.

The Master is divided into five teaching modules that develop the following themes:

2. MODULE II - CLINICAL STUDIES
3. MODULE III - DATA MANAGEMENT AND EXPLOITATION

**Total hours:**

The Master is structured in 1500 hours, for a total of 60 CFU, of which:

- 240 hours of face-to-face lectures;
  - 375 hours of the internship;
  - 125 hours for the final test;
- and the remaining hours in individual study activities.

Intermediate tests include 5 multiple-choice quiz and 3 open questions of 300 words. A final test consisting of the discussion of the thesis work is also foreseen. The thesis work is performed by the Candidate on a subject of choice that can also be related to the training performed during the internship period.

**Teaching staff:** The teaching staff consists of lecturers chosen from experts and professionals with proven expertise in the field, who have gained high experience in the topics covered by the Master.



**Selection procedure:** *Curriculum Vitae et Studiorum* evaluation and interview.

Selection will be based on qualifications and work experience (50%) and a motivational interview (50%).

## **ARTICLE 2 - Admission requirements**

Participation in the selection process is open, without age or nationality restrictions, to those in possession of a qualification obtained in Italy, as specified in Art. 1 of the present call, or a similar academic qualification obtained at a foreign university.

Applicants with a foreign academic degree must send the documents needed to verify it (degree certificate with exams; or description of the degree with a list of exams taken, using facsimile *Annex B*) to the Life Sciences Department (Via Campi 103, 41125 Modena, Italy), attaching the document to the application using the computer procedure indicated in Item 3.

Italian and foreign citizens in possession of a foreign academic qualification must present the following documentation by the deadline for enrolment, in compliance with the regulations in force regarding the admission of foreign students:

- qualification translated and legalised by the Italian Representation (Embassy or Consulate) in the country in which it was obtained;
- "dichiarazione di valore in loco " to be requested from the same Representation.

The information provided by candidates will be carefully checked by the relevant departments to ensure that it is accurate.

Candidates are admitted to the selection procedure after verification of the above requirements.

## **ARTICLE 3 - Applications for admission**

The applications for admission to the selection procedure and any other documents (qualifications and documents deemed useful for the selective procedure) must be submitted to this Administration, under penalty of exclusion, within the peremptory deadline indicated in art.1, exclusively using the following computerised procedure:

### **Via the Internet:**

1. Register on the site [www.esse3.unimore.it](http://www.esse3.unimore.it), a page that can also be accessed at <http://www.unimore.it> - *Servizi - Servizi informatici - Lo sportello ESSE3*, then:
  - a. If you are a former Unimore student, you can log in using your esse3 credentials;
  - b. If you are not a former Unimore student but you are an Italian Citizen aged 18 you must log in with your SPID credentials (Sistema Pubblico di Identità Digitale);
  - c. If you are not a former Unimore student, nor an Italian Citizen (EU or non-EU), or if you are an Italian aged under 18, you have to register to the esse3 website and create a new account, then log in using the received credentials.
2. Once you have logged in, in the Student Area, follow "Admission" - "Enrolment" - "Master".

All the titles and documents considered helpful for the selection procedure must be attached exclusively in electronic format *.pdf* or *.rtf* with a maximum size of 20 MB. Attachments larger than 20 MB must be divided into several parts.

**Applications for admission, submitted according to the above-mentioned procedures, are submitted in due time only if received by this Administration within the peremptory deadline of the call.**

During the computerized application procedure, the candidate must declare under his/her responsibility:

- b) the place and date of birth;
- c) residence, telephone/cell phone number, address for admission purposes, and e-mail address;
- d) tax code (for those who already have one; those who do not have a tax code will only have to confirm the one automatically calculated by the system);
- e) citizenship;
- f) possession of an academic qualification or similar academic qualification obtained at foreign universities;
- g) the exact name of the Master's Programme in which they intend to participate;
- h) Curriculum Vitae et Studiorum;
- i) titles and any other documents;
- j) In the case of candidates with disabilities, following law no. 104 of 5 February 1992, the type of aid needed to sit the exams.

By applying for admission, the candidate undertakes at the same time:

1. to communicate promptly any change of residence or address;
2. In the case of an Italian citizen or a foreigner in possession of a degree obtained abroad, send the degree itself, with a list of the exams taken and accompanied by an Italian translation, legalization, and "declaration of value in situ" by the Italian diplomatic-consular representation competent for the territory, in compliance with the regulations in force regarding the admission of foreign students to degree courses at Italian universities, within the deadline for enrolment.

Applicants may be notified of their exclusion at any time, *ex officio*, for failure to meet the eligibility requirements. Applications submitted or received after the deadline or in a manner different from that specified in this notice will not be considered.

The Administration accepts no responsibility in the event of the loss of communications due to incorrect information or failure to provide or late notification of a change of address, as well as technical problems or events attributable to third parties, unforeseeable circumstances, or force majeure. Furthermore, the Administration accepts no responsibility in case of non-receipt of documents due to facts attributable to third parties, as well as in case of errors by the candidate in the insertion of attachments and any case of network downtime.

#### **TITLES and DOCUMENTS:**

Candidates will have to attach, through the informatic system, to the application form:

- "Annex A" for candidates in possession of a qualification obtained in Italy, self-certification of possession of the access requirement under articles 46 and 47 of D.P.R. 445/2000 using the facsimile at the end of the application form;
- "Annex B" for candidates with a degree obtained abroad, a degree certificate with exams or a description of the degree with a list of the exams passed, using if necessary the facsimile at the end of the application form;
- Titles and documents considered useful for assessment and list thereof;
- Curriculum vitae et Studiorum;
- Copy of a valid ID card.

Under art. 15 of Law no. 183 of 12 November 2011, it should be noted that certificates issued by the public administration regarding status, personal qualities, and facts are valid and usable only in relations between private individuals. In relations with public administration bodies and public service managers, certificates and deeds of notoriety are always replaced by the declarations referred to in articles 46 and 47.

The certificates issued by the competent authorities of the State in which the qualification was obtained must comply with the provisions in force in that State and must also be translated and legalised by the competent Italian consular authorities.

Acts and documents drawn up in a foreign language must be accompanied by a translation into Italian, certified as conforming to the foreign text, drawn up by the competent Italian diplomatic or consular representation or by an official translator.



#### **ARTICLE 4 - Admission procedures and publication of the ranking list**

The method of selection is set out in Article 1.

At the end of the selection procedure, the Selection Committee will draw up the final merit list.

Candidates will be admitted to the Master's Programme by the provision of the Director of the Department of Life Science, Prof. Lorena Rebecchi, once the regularity of the documents has been ascertained, according to the order of the ranking and up to the number of places available for the Master's Programme.

The ranking of those admitted will be made public through publication on the online public notice board available at the link <https://wss.unimore.it/public/albo/> and also on the University of Modena and Reggio Emilia website <http://www.unimore.it> - Didactics - Master's Programmes - Admitted Graduations.

**NO INFORMATION WILL BE GIVEN BY PHONE OR SENT TO YOUR HOME ADDRESS**

**Enrolment in a Master's Programme is compatible with ongoing enrolment in another course of study, a degree course, a master's degree course, a specialisation course, or a Ph.D. Programme, and another university master's program.**

Enrolment in a Master's Programme is incompatible with an active training period (TFA).

#### **ARTICLE 5 - Registration of those admitted**

Under penalty of forfeiture, within the peremptory term of twelve days starting from the day after the publication of the final ranking on the University online public notice board, candidates who are successfully placed in the final merit list must enroll in the Master's Programme exclusively via the Internet.

Go to the University website: <http://www.esse3.unimore.it/Home.do> and log in, follow the path in the Student Area: "Immatricolazione" - "Immatricolazione ai corsi ad accesso programmato".

Candidates who are successfully placed in the final merit list must confirm the data already entered when submitting the application form and must print the application form for enrolment in the Master's Programme.

After filling in the application form, go to [www.esse3.unimore.it](http://www.esse3.unimore.it). After logging in, go to the heading Fees to view the amounts due to make the payment of contributions. The payment must be made, under penalty of exclusion, within the peremptory deadline mentioned above.

The payment of the second installment must take place within the deadline established in Art. 1 of the present call, exclusively in the same way as above. In case of late payment of the second installment, there will be a surcharge of € 30,00 up to 15 consecutive and continuous days after the deadline and of € 70,00 from the 16th day onwards.

The mere payment of the first installment and the printing of the above-mentioned forms do not complete the enrolment in the Master's Programme.

Candidates, under penalty of forfeiture, within the peremptory term of twelve days, starting from the day after the publication of the final ranking, must send to the Marco Biagi Foundation (Largo Marco Biagi 10, 41121 Modena, Italy) by DIRECT DELIVERY during the days and hours open to the public (by appointment to be agreed upon with the secretary) or by PEC (at [fondazionemarcobiagi@pec.unimore.it](mailto:fondazionemarcobiagi@pec.unimore.it)), RACCOMANDATA A.R. LETTER, or POSTAL COURIER the following documentation:

- a) **signed Application Form;**
- b) **receipt of payment of the first installment of the registration fee.**

Italian and foreign citizens in possession of a foreign academic qualification must submit to the Marco Biagi Foundation, under penalty of exclusion, by and no later than the deadline for enrolment, as indicated above or by E-MAIL to the following address [master.biopharmaceuticals@unimore.it](mailto:master.biopharmaceuticals@unimore.it) the degree certificate with the list of exams passed, accompanied by an Italian translation, legalization, and "declaration of value in loco" by the Italian diplomatic-consular Representation competent for the territory.

Foreign citizens not yet in possession of a tax code will have to apply for one at the Revenue Office (once they have entered Italy) and will have to send a copy of the card issued by the latter, within 30 days from the beginning of the Master's course, to the secretary's office, exclusively by email [master.biopharmaceuticals@unimore.it](mailto:master.biopharmaceuticals@unimore.it).

Those who will not have provided to regularize their registration in the terms and the manner indicated above will be considered renounced.

Anyone making false declarations will be excluded.

Vacancies will be allocated to other candidates in the order of the final list of merit.

If at the end of the selection procedures there are still places available, applications for admission submitted after the deadline for late applications and before the date of the start of classes may be taken into consideration with the payment of a late fee of 30.00€ on any registration.

If the minimum number of enrolled students is not reached, the activation of the master will be revoked, in which case the fees paid will be refunded.

## **ARTICLE 6 - Attendance procedures**

Class attendance is mandatory and the minimum requirements for the award of the degree are:

- 80% of the hours of frontal teaching, in presence or at distance;
- Attendance for a period of no less than 90% of the total duration of the internship;
- Passing the intermediate verification tests;

- Passing the final test.

#### **ARTICLE 7 - University credits and qualifications awarded**

The University Master's Programme, as per Art. 1, confers 60 university credits as provided for by Art. 2, paragraph 5 of the University Regulations governing University Master's Degrees and Advanced Training Courses, professional refresher courses, and preparation for state examinations to qualify for the exercise of professions and public competitions.

At the end of the master, upon passing the final test, the title of II Level University Master Programme in **Development, Manufacturing, and Authorization of Biopharmaceuticals** will be issued. The achievement of the title is subject to being in order with the payment of taxes and contributions and any surcharges.

#### **ARTICLE 8 - Processing of personal data**

The University Administration, by current legislation, undertakes to use the personal data provided by the candidate for the completion of the selection procedure and institutional purposes.
