Teaching activities will concern all the disciplines of the ssd GIUR-04/A taught in the degree courses of the Department of Law (Laurea Magistrale in Giurisprudenza and Laurea triennale in Scienze Giuridiche dell'Impresa e della Pubblica Amministrazione), as well as in other degree courses of other Departments in which teaching is active under the ssd GIUR-04/A. Other teaching activities may be required as part of the PhD programme in Legal Sciences. The scientific activity will concern the subjects included in ssd GIUR-04/A, with specific focus on the problems emerging from the public and private entities nationals and of the Modena-Reggio Emilia area. Particular attention will have to be paid to the issues of demography and welfare systems

Admission requirements

Candidates in possession of the following titles will be admitted to the selection procedure:

- Research doctorate (or equivalent if obtained abroad) or Diploma of Medical Specialisation;

The selection is open to candidates who have had contracts regulated by art. 24, sub-section 3 - a), Law nr. 240/2010 (junior), or candidates who got the National Scientific Qualification for the positions of Full and Associate Professors according to article 16 Law nr. 240/2010, or candidates who have obtained a Specialisation degree in medical area, or candidates who have had research grants for three years minimum, not necessary consecutive, regulated by article 51, sub-section 6, Law nr. 449/1997 (as afterwards amended) including research grants regulated by art. 22 of law 240/2010 or postdoctoral grant regulated by article 4, Law nr. 398/1989 or equivalent contracts, research grants or grants at foreign Universities or persons who have had contracts for three years minimum, regulated by article 1, sub-section 14, Law nr. 230/2005.

To obtain the required period of three years, the activities above mentioned can be cumulated.

Candidates must be in possession of above mentioned requirements at the application deadline in order to gain admission to the selection process.

The Administration guarantees fairness and equal opportunities for men and women in terms of work access and contractual conditions.

How to apply and deadline

The date of submission is certified by the electronic system, that will send a receipt by mail. After the deadline, it will be no more possible to edit and submit the electronic form. To each application will be assigned an ID number, which has to be used for following communications together with the competition code

The date and the time of submission is certified and proven by the electronic system, that will automatically send a receipt to the applicant's mail, after the submission of the application. Candidates in possession of the necessary titles must also attach the following to the application:

- 1) a curriculum vitae of the candidate's scientific and teaching activities as well as the curriculum vitae of clinical/assistance activities for the scientific disciplines in which this is required;
- 2) titles and documents believed useful for purposes of comparative evaluation and relative list of such documents;
- 3) scientific publications and relative list, presenting authenticated copies/photocopies. In the latter case, the candidate will have to present a statement substituting the affidavit as defined in attachment B. This declaration will have to be signed before the official who receives the documentation, i.e. presented together with a photocopy of a form of ID belonging to the signer.

The failure to comply with the maximum number of publications limit, will imply the exclusion of the candidate.

Documents and titles attached must correspond to the requisites as described in art. 3 of the original Italian text to which candidates should refer.

Participation in the selection process requires the payment of a non-refundable contribution of 30 (thirty) Euros, as a forfeit coverage of the selection process expenses.

Evaluation Procedure

The comparative evaluation provides a preliminary assessment of the candidates with analytical judgment motivated securities, CV and scientific output, including the thesis, according to the criteria and parameters which

are also recognized in the international area of research, in the manner determined by the DM No 243 of May 25, 2011.

This notice will serve as notification for all those who take part in the selection process, who may be admitted "with reserve" and thus required to be present on the day and at the time and place stated, without any further communication.

The absence of the candidate will lead to his/her automatic exclusion from the selection process. Candidates must come to the interview with a valid form of ID.
